THE PROGRAM SERVES THOSE UNDER 40 YEARS OF AGE WHO ARE NOT ELIGIBLE FOR THE STATE PROGRAM (FOR 40 AND OVER). CLIENTS ARE LOW-INCOME AND UNINSURED.
